#### PURPOSE

This specification details the required standards to deliver our Raising Claims and satisfy all requirements for the export and labelling of our lamb products to multiple global markets.

#### **SPECIFICATION**

- All lambs supplied to this specification will be Free Range, Pasture Fed and have year-round access to grass (e.g. hay, silage, lucerne or non-grain feed crops), and the only permitted supplementary feedstuffs are NZ non-grain grown fodder crops.
- 2. Antibiotics are not routinely used in the production of Quality Assured lambs.
  - Should any antibiotics be administered to lambs as an individual animal treatment, this stock must be identified at the time of treatment and separated from untreated stock prior to transport off the property and supplied under a separate ASD.
  - Lambs administered with antibiotics will fail to qualify under this specification.
- 3. Lambs under this specification will comply with NZ law where it is an offence to:
  - a. Feed ruminant protein in any form, composition, or admixture to sheep or lambs.
  - Administer any Hormone Growth Promotants (HGPs) to sheep or lambs.

- 4. Currently
  - a. No HGPs have been registered for use in sheep or lambs in NZ.
  - b. \*Currently no GMOs have been approved for introduction into NZ.
  - c. \*No GM seeds have been approved for release into the NZ Environment.
  - d. \*No fresh fruit, vegetables or meat sold in NZ are genetically modified.

- Lambs supplied under this specification will not have been fed any grain or grain by-products or compounded or imported or manufactured feed in their lifetime.
  - Should any lambs be fed any such feed they will fail to qualify under this specification.
- 6. For any and all lambs supplied under this specification that were not born on your property, a signed copy of both this Specification / Declaration and appropriately completed ASD will be obtained from the previous owner and be retained by the supplier of stock to the plant for a minimum of two (2) years and be available within 48 hours when required for audit purposes.
  - The processing plant representative and/or an independent third party will audit samples of these declaration documents and accompanying ASDs for validity.
